ORDINANCE NO. 877

AN ORDINANCE REPEALING ORDINANCE NO. 317, ESTABLISHING AN ANNUAL PRIVILEGE LICENSE TAX FOR VARIOUS BUSINESSES, TRADES, VOCATIONS, OCCUPATIONS OR PROFESSIONS WITHIN THE CITY OF WARREN, ARKANSAS, PROVIDING FOR THE AMOUNT THEREOF, AND FOR OTHER PURPOSES:

WHEREAS, the City Council has made careful research and has ascertained that various privilege taxes are inequitable; and

WHEREAS, Ordinance No. 317 should be repealed and privilege taxes should be set as herein described.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WARREN, ARKANSAS:

SECTION 1. That the carrying on of any business, occupation or profession of whatever kind or nature within the City of Warren, Arkansas, is hereby declared to be a privilege, and from and after the effective date of this Ordinance any person, firm or corporation, engaged in any business, occupation or profession of whatsoever kind or nature within the City of Warren shall pay an annual privilege tax for the privilege of carrying on such business, occupation or profession within the City of Warren. The privilege tax as provided herein to be paid by the person, firm or corporation engaging in any business, occupation, or profession, shall be as follows:

SECTION 2. The taxes as provided herein for the calendar year 2014 shall be due and payable January 1, 2014. Commencing with the year 2014, the taxes herein provided shall be due and payable in advance for each calendar year hereafter beginning January 1, 2014. Penalties for failure to pay the privilege tax provided in this Ordinance shall be ten percent (10%) of the amount due when the payment is made after March 1 of any calendar year. Citations to appear in Warren District Court for failure to pay will be issued by the City Building Code Department.

SECTION 3. It shall be the duty of the City Clerk upon receipt of the amount of the privilege tax provided to herein issue a receipt under this Ordinance for every person, firm or corporation liable to pay such tax, and to state in each receipt issued the amount thereof, the period of time covered thereby, the name of the person, firm or corporation to whom issued, the business, occupation or profession to be carried on, and in no case shall any mistake in stating or computing the amount of the tax due prevent or prejudice the collection by the City of what shall actually be due under this Ordinance.

SECTION 4. Any person, firm or corporation engaging in more than one business, occupation or profession shall pay a separate privilege tax for each such business, occupation or profession.

SECTION 5. It shall be unlawful for any person, firm or corporation, whether as principal or agent, to commence, engage in, or carry on any of the aforesaid businesses, occupations or professions within the City of Warren without have first paid the privilege tax as herein provided on or before the prescribed date that penalty attaches.

SECTION 6. The period covered by taxes paid shall be for one calendar year or a part thereof.

SECTION 7. The receipt issued hereunder shall not be transferable.

SECTION 8. Any person, firm or corporation doing business in the City of Warren without the payment of the privilege tax herein above provided, and without having been issued a receipt to transact its business shall, upon conviction in the Warren District Court, be deemed guilty of a misdemeanor and shall be fined in a sum not less than \$50.00 nor more than \$5,000.00, and each day of violation shall constitute a separate offence.

SECTION 9. It shall be unlawful for any person to knowingly and willfully make a false written affidavit as to number of persons engaged in such business or to file such false affidavit with the City Clerk or any Deputy Clerk, for the purpose of defrauding the City of Warren by procuring a receipt for a lesser sum that is lawfully due.

SECTION 10. The term "person" as used in this Ordinance refers to the total number of individuals actively engaged in such business, including the individual owner, or owners, managers, supervisors and employees.

SECTION 11. Should any word, section, or part of a section or provision of this Ordinance be for any reason held unconstitutional, void or invalid, it shall not affect the validity of any other word, section or provision thereof which is itself not void or invalid.

SECTION 12. All Ordinances or parts of Ordinances in conflict herewith are hereby repealed, particularly Ordinance No. 137, 3/7
